Introduction

The General Assembly of the Government of Norfolk Island has established the Select Committee on Norfolk Island Asset & Resource Base to identify, document, and assess Norfolk Island's assets, resources, infrastructure, economic foundations, and future opportunities.

The Committee has been established to support long-term sustainability, economic resilience, responsible stewardship, and community prosperity.

The Government of Norfolk Island now invites Expressions of Interest from members of the Norfolk Island community wishing to participate in this important work.

Purpose of the Committee

The Committee will assist Norfolk Island to develop a comprehensive understanding of its asset base, economic foundations, resource opportunities, and long-term sustainability needs.

The Committee's work will support informed decision-making and help identify opportunities that strengthen community wellbeing, economic resilience, youth opportunity, environmental stewardship, and intergenerational prosperity.

Areas of Inquiry

The Committee may consider:

- land and property assets;
- natural and environmental resources;
- marine resources;
- infrastructure and public utilities;
- tourism and visitor economy opportunities;
- business and economic development;
- workforce participation and skills development;
- youth opportunity and retention;
- community wealth and stewardship models;
- sustainable revenue opportunities; and
- long-term economic resilience.

Who Should Apply?

Applications are encouraged from people with experience, interest, or knowledge in areas such as:

- business and commerce;
- finance and accounting;
- tourism;

- infrastructure and utilities;
- environmental management;
- agriculture and primary industries;
- property and land management;
- planning and development;
- education and workforce development;
- community organisations; and
- sustainability and resource management.

The Government also welcomes applications from community members who possess practical local knowledge, lived experience, industry experience, or a strong interest in Norfolk Island's future prosperity.

Committee Membership

The Committee will comprise:

- a Chair appointed by the Government of Norfolk Island; and
- up to six additional members.

Appointments will seek to ensure a balanced mix of skills, practical experience, community perspectives, and generational representation.

Time Commitment

Members should expect to:

- attend Committee meetings;
- review information and research materials;
- participate in consultation activities;
- contribute to reports and recommendations; and
- engage with stakeholders where appropriate.

Appointment Process

Expressions of Interest will be assessed having regard to:

- relevant knowledge and experience;
- diversity of perspectives;
- community representation;
- practical expertise; and
- the overall balance of the Committee.

Appointments will be publicly recorded.
